**Called to order:** 4:00 p.m. by Chairperson Darris Flanagan

**Public Comment:**

**Unfinished Business, Item a moved**

- a. Participation Agreement with U.S.F.S., Nathan Gassman, Libby District Ranger
  - Mr. Gassman stated the Libby District is experiencing expansion in their capacity, but there is not enough staffing. To assist with this, as an example, Yaak Valley Forest Council has assisted in coordinating projects.
  - The next project will include the Flower Creek Watershed. Funding is available for forestry concerns, for example, road systems. An analysis is currently in process. Once the analysis is complete he (Nate Gassman) can return to the LCD Board with a specific project and the need; for example, financial support or contracting services. Mr. Gassman is aware of our (LCD) concern for audit costs should our revenue exceed the state audit requirement.
  - Darris Flanagan asked about funding District staff costs.
  - Mr. Gassman explained it depends on the project; it could be as simple as a letter of support.
  - Darris Flanagan agreed; it depends on the project cost as to the administrative cost.
  - Mr. Gassman presented examples from the Flower Creek Watershed and the current analysis.
  - Alfred Phillipy asked how far ahead is the analysis.
  - Mr. Gassman replied the completion date is December 15<sup>th</sup>.
  - Wayne Maahs noted we (LCD) have discussed at three Board Meetings, three variations of the support the Forest Service is requesting. For example, the Trout Creek Participation Agreement and Yaak Valley Forest Council; two different types of support.
  - Mr. Gassman responded he will next present a specific project for the Board to review after the completion of the analysis of Flower Creek.

- Wayne Maahs noted to Mr. Gassman, the Forest Service needs to realize our (LCD) capacity; we are a seven-member Board and staff. Hannah Hernandez had previously mentioned contracting/administration of contracts.
- Mr. Gassman spoke on the bio mass proposal for Libby schools. The Forest Service has funding available for those types of programs.
- Wayne Maahs replied we (LCD) would be supportive however, we are not the “drivers” of the project; the school superintendent would be. We (LCD) has a M.O.U. currently with the Forest Service which could be expanded.
- Darris Flanagan commented the Eureka School District experienced an issue with finding a source for the bio mass fuel. He advised Mr. Gassman to be certain to have a source.
- Mr. Gassman agreed a source needed to be found. It is unfortunate we have the resources here in Lincoln County but not the distribution system. The fuel must be transported from elsewhere.
- Mike Justus presented to Mr. Gassman the upcoming Forestry Field Tour being held the last week in October. Flower Creek was a recommended location for the tour.
- Mr. Gassman noted this would be a good location for a field tour, in fact a field trip has been scheduled for Forest Service supporters on September 1<sup>st</sup>.
