**Public Comment:**

**310 Permit Application(s) Moved**

**Li-09-05-15 – Hageness, Kootenai River**

- Wayne Maahs reviewed the project.
- Mr. Hageness apologized for the work that had been completed without a 310 permit. It is his full intention to “make it right”.
- Wayne Maahs and Mike Hensler conducted the on-site. The roots of the removed plants have not been damaged. The recommendation is to do nothing but water to bring back the existing vegetation.
- Mike Hensler agreed adding the water every other day.
- Wayne Maahs added should the existing vegetation not come back, then plant with native vegetation.
- **Motion** by Wayne Maahs to accept Li-09-05-15 as presented. **Second** by Don Crawford. **Motion passed.**

**Li-09-09-15 – Cole Flower Creek**

- Don Crawford reviewed the project; NRCS had previously rip-raped the area. The original rock had asbestos; EPA brought in replacement rock.
- Mr. Cole reported the replacement rock was not placed correctly and the rocks are relocating themselves. There was never a problem with erosion until the rocks were replaced.
- Don Crawford explained the plan is to take the loosened rock, plus other rock from the site and armor 60 feet of the embankment. The plan includes removing larger rocks from the gravel bar.
- Kirk Sullivan asked did the rocks move because they were not keyed in.
- Mr. Cole responded they were not keyed in. He wants to key the rocks in. The bank is about 15 feet tall.
- Don Crawford commented as long as the project stays off of the far bank there should be no issues. Someday he may have to lay back the embankment.
- Kirk Sullivan asked how deep with Mr. Cole key in the rocks.

- Mr. Cole responded 1 ½ feet at least. The creek can have a very powerful flow. He plans to key in deep enough so not to have to do the work again.
- **Motion** by Don Crawford to approve Li-09-09-15 as presented; waive 15 day wait period. **Second** by Wayne Maahs.
- Mark Romey asked how this effects the dam upstream from the project.
- Mike Hensler replied it has no effect.
- **Motion passed.**

**Li-09-07-15 – Thompson, Bobtail Creek**

- Wayne Maahs described the location and project. The Thompson's have hired Todd Butts to develop the design. Wayne and Don Crawford conducted the on-site. Everything Todd was planning to implement is feasible.
- Mr. Thompson explained without the project the neighbors will be effected by high water. The project needs to be completed before spring run-off.
- Don Crawford commented another project was done years ago.
- Mr. Thompson described the previous project.
- Don Crawford added the area was fenced to keep out cattle.
- Mr. Thompson was told cattle were causing erosion and placed fencing on both sides of the channel to keep cattle out. He commented he probably did not plant enough alders before to reduce erosion.
- Don Crawford commented Todd's plan looked reasonable.
- Mike Hensler added it is good to keep the cattle off. The stream is trying to meander. Todd is planning to straighten, but he is taking down the bank; this should be okay.
- Mr. Thompson noted the existing 90 degree bends were 45 degrees.
- Mike Hensler noted when you straighten out a channel the speed of the water increases, causing more gravel movement.
- Mr. Thompson stated the project is not straightening but placing the channel at 45 degrees.
- Don Crawford commented you (Mr. Thompson) have been a good steward. Your proposal is good and will ease the situation. None of us know how long it will last. The channel has wanted to meander. This is a reasonable proposal.
- Wayne Maahs asked Mike Hensler if he would suggest a grade control be added.
- Mike Hensler commented with a grade control there would still be a problem but the floodplain will help.
- Don Crawford added vegetation will help.
- Mike Hensler agreed vegetation will be important. With the possibility of a mild winter the vegetation should be able to get established.
- Mike Justus suggested 6 foot fencing to protect the vegetation that are in the plan. This would be a less expensive option than what is in the plan to keep the deer from browsing.

- Kirk Sullivan noted from Todd's report the issue is constriction and not knowing the pebble size we don't know if down cutting is an issue; but will keep in mind.
- **Motion** by Don Crawford to accept Li-09-07-15 as presented and include on the decision form to consider building in grade control. **Second** by Wayne Maahs. **Motion passed.**

**Li-09-01-15 – Roose, Mud Creek**

- Darris Flanagan explained this 310 annual maintenance permit application is for a dam on Mud Creek.
- Mr. Roose provided an aerial map of the location and described the history to the dam and project. He has applied for a 404 permit with the Corps of Engineers and is waiting for the decision.
- **Motion** by Don Crawford to approve Li-09-01-15 as presented; waive the 15 day wait period; the permit is contingent on approval of all other permit; 10 year maintenance permit.
- **Second** by Mark Romey.
- Mike Hensler commented the 10 year maintenance plan may create some issues. It is easy to re-file if needed.
- Mr. Roose noted the application allows for an annual maintenance.
- **Motion failed.**
- **Motion** by Don Crawford to approve Li-09-01-15 as presented provided all other permits are in place. The permit is valid for one year. **Second** by Mark Romey. **Motion passed.**

**New Business – Item C Moved** Roose, Conceptual Design /223 Grant

- Staff reviewed the status of the proposal. Mr. Roose approached the District to sponsor a DNRC Reclamation Planning Grant to create a restoration plan for a section of Mud Creek. Staff recommended to create a conceptual plan first. After discussing with Alicia Stickney from DNRC, it was agreed the project would not qualify under a reclamation grant. Staff then checked with Laurie Zeller and this project would qualify for a DNRC 223 grant for up to \$20,000.00.
- Mr. Roose described his project.
- Mike Hensler added there are other opportunities for funding, for example Future Fisheries.
- **Motion** by Mike Justus to sponsor a DNRC 223 to develop a conceptual plan along Mud Creek for Barry Roose. **Second** by Valene Goff. **Motion passed.**

- Sixteen applications have been received for 2106. Thirteen applications that were not funded from 2105 will also be considered for 2016 funding.
- The Conservation Stewardship program has 2 forestry contracts
- A team from Bozeman are visiting from the state and area office today to conduct Quality Assurance reviews.
- The Barnaby Fire threatened the SNOTEL equipment site on Stahl Peak. Crews are conducting repairs and bringing the site back on line.

**Li-09-02-15 – Ruffinen, Grave Creek**

- Darris Flanagan described the project history. Mr. Ruffinen want to divert the water in the channel to the opposite bank by bringing in large rocks.
- Mike Hensler commented the rocks will end up in the middle of the creek. He suggested to raise the elevation to allow the water but not the substraight.
- Darris Flanagan stated the concern is with the rocks going into the overflow.
- Mike Hensler added there is a chance of movement but it could be devastating when the creek flows.
- Darris Flanagan drew a diagram to demonstrate the proposed project.
- **Motion** by Don Crawford to table Li-08-01-15 for an on-site inspection on Wednesday, October 21<sup>st</sup> **Second** by Wayne Maahs. **Motion passed.**

**E-09-03-15 – Clowers, Edna Creek**

- Darris Flanagan explained none of the proposed emergency action has taken place. The only work done is painting of the steel beams to be used.
- **Motion** by Mike Justus to declare E-09-03-15 not an emergency. **Second** by Wayne Maahs. **Motion passed.**

**Li-09-04-15 – Clowers, Edna Creek**

- **Motion** by Mike Justus to approve Li-09-04-15 as presented; waive 15 day wait period. **Second** by Mark Romey. **Motion passed.**

**Li-09-06-15 – Raynor, Seventeen Mile Creek**

- Mike Justus reviewed the application. The project area has been accessed in the past. The span is too wide for a culvert. This is a one-time access and will be completed by October 31<sup>st</sup>.
- **Motion** by Wayne Maahs to approve Li-09-06-15 as presented; waive 15 day wait period. **Second** by Don Crawford. **Motion passed.**

**Li-09-08-15 – Yaak Valley Forest Council, Clay Creek**

- **Motion** by Wayne Maahs to approve Li-09-08-15 as presented. Include in the decision form for applicant to notify the Supervisors of when the project will occur to observe the technique. **Second** by Mark Romey. **Motion passed.**

**C-09-10-15 – Johnson/Yorlum Ranch, Brimstone Creek**

- Mike Justus conducted an on-site from the adjacent property. There was no alteration or modification to the streambank. This appears to be a water rights issue.
- **Motion** by Mike Justus to declare C-09-10-15 as not a violation; no modification to the streambank. **Second** by Valene Goff. **Motion passed.**
