 - **Motion** by Don Crawford to sponsor two (2) ranchers for the registration and hotel accommodations to the Western Montana Grazing Conference. If in the event we do not have any attendees, the District will provide a \$100.00 sponsorship donation. **Second** by Mark Romey. **Motion passed.**

Unfinished Business:

- a. Grant Update.

- 1. Tobacco River - Kassler
 - A. Phase 1 – DEQ 319 Grant
 - Staff is coordinating with Dave Martin, DNRC the Request for Qualifications/Bids.
 - B. Phase 2 - DNRC Reclamation Grant Application
 - The Governor's Budget was released. We received an e-mail from DNRC noting the ranking and funding. The Tobacco River Restoration Project was ranked 8th with the top seven (7) funded, if approved by the legislature. Three million dollars are available.
 - Staff reported on the three other grant applications in Lincoln County. These grants were requested under the Renewable Resource grant program. She does not know if they will be funded.
 - Town of Eureka – Ranked 30th
 - GLID – Ranked 37th
 - Lincoln County – Ranked 57th
- 2. 223 GLID
 - Staff reported the grant extension request was approved.
- 3. Mud Creek - DEQ 319 Grant
 - Staff reported the 319 grant request was fully funded. The project conceptual design did not include the fish barrier. We will be seeking funding for this. Two possible funding sources are the MTFW&P Fisheries Grant program and unused funds from a Kootenai River Network and Lincoln County grant project for a culvert installation. Samantha Tappenbeck participated in a teleconference call with KRN to discuss funding. Jim Dunnigan is checking to see if the funds can be used for this restoration project.
