Item Added:

- Wayne Maahs explained a motion was inadvertently not made at the March 20, 2019 Board of Supervisors meeting to approve the sponsoring of the DNRC 223 application for the Lincoln County Weed District. This item was on the March agenda for discussion and approval. Wayne Maahs called for this item be added to the agenda and a motion as this time to approve the sponsorship.
- **Motion** by Don Crawford to sponsor and submit a DNRC 223 grant for the Lincoln County Weed District for weed treatment. **Second** by Tom Maffei. **Motion passed.**

- a. March 2019

- Staff noted we are at 87% of our budget and keep in mind we recently paid one of our largest invoices for this fiscal year, the 2019 MACD dues. Staff will have the FY 2019/20 Preliminary Budget next month.

NRCS Report – Brian Ressel

- Brian presented information on the TIP program. Funding will be for the next 5 years; 1,600 acres will be treated; acreages with homes will have priority; funding for fuels reduction and thinning.

- Brian Ressel responded, we always applications; there are “pots of money” available, for example the hoop houses and technical assistance.

310's:

Li-04-01-19 - Linnell, Mud Creek

- Kathleen Johnson reported on the project. The applicant will be installing a new septic system that will be bored under Mud Creek. A temporary culvert will be installed for access.
- Laura Garner added the septic line is a pipe within a pipe.
- **Motion** by Darris Flanagan to approve Li-04-01-19 as presented; waive fifteen day wait period. **Second** by Kathleen Johnson. **Motion passed.**

E-04-02-19 – McCully, Ksanka Creek

- Laura Garner described the emergency action taken. Due to debris in the culvert, water back flowed into the applicant's basement. Debris was removed from the ditch and culvert.
- **Motion** by Laura Garner to declare E-04-02-19 as an emergency action under the 310 Law. No mitigation is required. **Second** by Kathleen Johnson. **Motion passed.**

Li-04-03, 04, 05, 06, 07, 08-09 - InterBel, Brimstone Creek Bore #1 & #2, Fortine Creek Bore #1, Stillwater River Bore #1 & #2, No Name Creek Bore

- **Motion** by Don Crawford to approve Li-04-03, 04, 05, 06, 07, 08-19 as presented. **Second** by Darris Flanagan. **Motion passed.**

Li-04-10-19 – Vredenberg/Brewer, Therriault Creek

- Kathleen Johnson reported this project site is the oldest water right on Therriault Creek. The applicant will be replacing an old wood culvert.
- Darris Flanagan added the project will include the placement of a weir. This is a simple project.
- Laura Garner noted there will be minimal disruption to the creek.
- Kathleen Johnson added the new diversion will provide maximum efficiency.
- **Motion** by Kathleen Johnson approve Li-04-10-19 as presented; waive fifteen day wait period. Second by Laura Garner. **Motion passed.**

New Business:

a. Sweet Grass Conservation District

- Staff reported this Sweet Grass grant is the same program we applied for to complete vegetation of Phase I of the Tobacco River Restoration Project. This round of applications is for a maximum of \$13,000 per applicant. We would like to apply again to plant vegetation in Phase II.

- b. Montana Biological Weed Control Coordination Project Donation
 - Staff noted we made a \$50.00 donation last year. A few years ago Melissa from this organization made a presentation at our noxious weed workshop at Libby Dam.
 - **Motion** by Darris Flanagan to make a donation of \$50.00 to the Montana Biological Weed Control Coordination Project. **Second** by Tom Maffei. **Motion passed.**
- c. Staff Time Off
 - Staff reported she will be off ½ day on Wednesday, May 1st off, Thursday May 2nd and Tuesday, May 28th.
- d. Permissive Medical Mill Levy
 - Supervisors
 - Staff reported she recently learned supervisors are eligible for the permissive medical mill levy. For each supervisor who opts to participate in the mill levy, the District will have to pay the current monthly \$25.00 stipend. The one year stipend requirement is not needed since we have that established.
 - Laura Garner commented she would be interested.
 - Employees
 - Staff noted she may be asking for an increase in the mill levy due to an increase in health care premiums.

iii. Mud Creek - Roose

1. DEQ 319 Grant

- Staff reported we have \$1,600 remaining in the grant. We transferred \$2,700 from Administrative fees to construction to subsidize the cost overrun.
- Staff reported the landowner has approached her regarding the completion of the lower reach. Due to the overrun in costs for the upper reach, we used all the construction funds for that portion of the project.
- Darris Flanagan noted we (LCD) need to finish the current projects. We have spent money and time on this project and have other landowners interested in our assistance for restoration projects; put this project “down the road” for now.
- Brian Ressel noted the advertisement sign is still in place; maybe the work cannot be completed.
