C-10-02-22, Neumann, Phillips Pleasant Valley Fisher River Civil Penalty

- Rae Lynn H. said Caitlin Overland, the MACD attorney, emailed to say that Mr. Neumann was served by the Lincoln County Sheriff's Office on June 12. Mr. Neumann has 20 days from service of the complaint to file an answer or otherwise appear in court. If he does not do so, the next step would be to consider looking into filing a default.

Li-06-01-23, Noble, McGinnis Creek

- Don C. and Brian Stephens conducted the site inspection. Don said the banks are straight and he did not see a problem with what was proposed. The biggest concern would be staying far enough away from the bank, so it does not cave. The bank is very spongy. There is also an existing livestock entry point that could be used to cross with an excavator if needed.
- **Motion** by Don C. to accept Li-06-01-23 as a project and approve with modifications. The contractor should begin the project 3 ft back from the bank. One back and forth crossing is permitted at the livestock crossing. **Second** by Gary P.
- **Motion** passes unanimously.

Li-06-02-23, Fischer, Lewis, Tobacco River

- Don C. and Brian S. conducted the site visit. The current owner has not made any significant changes. The work was done prior to landowners purchasing the property. The owner took out existing steps and set down the flagstone on an existing gravel pad. The Previous owner also placed some rocks near the stream where erosion is taking place. Water is also coming down a channel from the

gravel pit. The current owners are selling the property and will disclose that erosion measures will need to be addressed and a 310 permit will be required.

- Gary P. and Brian S. conducted the site visit. A couple trees on a steep bank are being undercut by water. One spruce tree fell over. The neighbor is concerned the other trees may fall.

Li-06-08-23, Sims, Young Creek

- Gary P. and Brian S. conducted the site visit. The landowner has a small area next to the stream where she wants to remove weeds that are obstructing her view of the creek. This application is for a maintenance permit.
- **Motion** by Gary P. to accept Li-06-08-23 as a project and approve as submitted for a 10-year maintenance permit. **Second** by John D.
- **Motion** passes unanimously.

Li-06-09-23, Dunlap, Murphy Creek

- Gary P. and Brian S. conducted the site visit. The proposed project will be an improvement to the stream. It has been ditched in years past and is full of sediment. This will add sinuosity and vegetation. It is a nicely engineered project.
- **Motion** by Gary P. to accept Li-06-09-23 as a project and approve as submitted. **Second** by John D.
- **Motion** passes unanimously.

Postponed 310's.

1. **Li-04-01-23, Ekman, Tobacco River**
 - Postponed until the landowners are back in Montana.
2. **Li-04-03-23, Dugopolski, Pike Creek**
 - Kathleen J. said this project is the result of a violation where the LCD asked the landowners to remove sandbags from the stream. After discussion with the landowner, the team learned that this has been an ongoing problem and the previous landowner suggested continuing to add to existing layers of sandbags. Brian S. is concerned that the greater risk is in removing the sandbags.
 - **Motion** by Kathleen J. to deny the application. The applicant can leave the sandbags in place to prevent sedimentation and degradation downstream. The landowner is not permitted to add any more sandbags. If a future need arises to address water levels, the landowner must submit a 310 application. **Second** by Gary P.
 - **Motion** passes unanimously.
3. **Li-05-01-23, Voyles, Tributary of Laughing Water Creek**
 - Gary P. said the board discussed this application at the last meeting. More information was required to make a decision. The amendment indicates that the contractor will pump water out of the pond and release it on the other side of the driveway into the stream.
 - **Motion** by Gary P. to approve Li-05-01-23 as submitted. **Second** by John D.
 - **Motion** passes unanimously.

4. Li-05-03-23, Noble, Fortine Creek

- Gary P. said this is a project that needs to be completed. Garrett, the contractor on the project, said the rock will be fresh crush. The Riprap will be coming out of the ground. The intent is to have a 1:1 or 1:1.5 slope when finished. They will not be able to work from the tracks as there is not enough room. With the amendment, the contractor plans to work from the right of way, set supersacks at the edge of the creek, remove the roadway and then build a ramp. A base of 3-5' riprap will be placed and then begin building up towards the tracks. The road will be put back in place after the repairs are completed.
- **Motion** by Gary P. to approve Li-05-03-23 as submitted. **Second** by John D.
- **Motion** passes unanimously.

- **Resignations from Mike and Laura Garner**
 - Mike and Laura Garner have moved from the area and resigned their positions as supervisor, Vice-Chairman, Treasurer, Supervisor for Administrator, and Planning Board Representative.
 - **Motion by** Don C. to accept the resignations. **Second** by John D.
 - **Motion** passed unanimously.

- **Appoint CD representative to the Lincoln County Planning Department**
 - The existing board members feel taxed with current commitments and are not sure they can take on one more task. John D. asked if it is possible to discontinue our representation on the planning board. Rae Lynn will check to see if it is possible to just have Jesse Haag provide updates.
 - **Motion** by John D. to postpone. **Second** by Don C.
 - **Motion** passes unanimously.
- **Appoint Supervisor for District Administrator**
 - **Motion** by Don C. to appoint Gary P as the supervisor for the District Administrator. **Second** by John D.
 - **Motion** passed unanimously.
- **Elect Treasurer**
 - **Motion** by Gary P. to nominate John D. as Treasurer. **Second** by Don C.
