We have had additional bank erosion on our property due to N. Cernick moving material in the creek

Tuesday 12/16/2025 @ 1:26 pm. Hearing equipment working near the creek. I observed an excavator in the middle of Libby Creek. I recorded a video of the excavator scooping buckets of material from creek and attempting to make a berm to direct the creek. Prior to the berm action a log jam was removed, which also directed the creek. This action has compromised my property and cause erosion and tree loss now and possibly with the next high water event. Additionally, properties down stream could be at risk as well.

A large portion of NF-533 was washed out, and I believe he was attempting to divert water away from that area.

I have attached a video of small channels developing before he physically was in the creek. After more flooding, on 12/17/25, part of his berm was washed out. Because he had moved the log jam the channel he created remains.

By Mr. Chernick moving debris (log jam) and scooping material this action has compromised my property, bank + trees, as well as possible down stream properties.

A large section of NF-533 was washed out. I believe he was attempting to divert water away from wetland.

I believe when he saw me taking photos he quickly walked machine down to where he could get up on road (NF 533) and was out of sight.

I have several pictures + video one of Before and also him physically digging/scooping material.

Friday 11:30am I took video of small channels formed. The excavator removed a pile of trees + debris creating a main channel and piled a large berm. After more flooding on Wed 12/17 part of his berm was out.

The excavator was in the creek more than an hour. Other neighbors heard it working but did not observe.
